July 2023 Minutes				

The DAC acknowledged the particular challenges of this case in weighing up the superlative significance of the building and the items proposed for change, and the robustly evidenced need for flexible space. As such, there were sufficiently mixed views among the committee members that it was only with some difficulty that a consensus was reached. It was noted that Englefield benefice had been broken up after years of discord and that the socio-economic demographic of the parish is now less prosperous as a result of this separation. It is also acknowledged that tremendous mission and outreach are taking place here, which evidences a robust need for space and facilities to accommodate 70+ people flexibly on a regular basis. The committee's feedback on each aspect was as follows:

- The committee largely welcomed the changes to the west end proposals concerning the WCs, creche, relocation of the font and provision of a tall storage cupboard and AV console. The servery at the west end of the north side of the nave was considered acceptable, though it was commented that it projects a little too far south and would be better to be slightly shortened here. The details for these aspects can be agreed with the subcommittee and will not need to return to the full committee.
- Concerning the pews, the committee recommended that permission ought to be sought for a trial adaption of a pew, and the visual and practical results of this be reported to the committee for it to

ascertain how sympathetically this could be executed and therefore whether the making moveable of the pews *en masse* would be acceptable. It was considered that the method of pew adaption would have to be of the highest quality and that what has been permitted in other churches with pews of lower significance, i.e. casters added in a way which makes the pew appear to be slightly floating off the ground, would not be desirable here. Any new joinery -i.e. for the new end required for the side of the pews currently fixed to the wall paneling- would need to be stable, sensitively designed and carefully coloured to match the existing. It was recommended that hydraulic systems where the casters can be retracted be considered amongst the methods for making the pews moveable. Since you already have a loose pew at the west end of the south side of the nave, it would make sense for this to be the one trialed for adaption.

- A majority of the committee was not averse to the principle of the proposed removal of four pews as a maximum, but considered that the frontals fulfil a useful privacy function and would lend an intentional look to a retained block of pews, and so ought to remain. It was also commented that, as and when the DAC agrees to the removal of the four pews, these ought not to be removed permanently from the site.
- The DAC considered that the J.O. Scott choir stalls are very fine and actually quite usable in their ability to seat choir members. The committee was concerned that it would be extremely difficult and costly to adapt them sensitively given their tiered construction and the fact that the decorative floor scheme is built around them. It was considered that the proposals would result in a tokenistic partial retention, and that the making good requirements would be too costly and impractical to be worth the gain. Given the contentiousness of this from the point of view of the DAC and statutory consultees, together with the committee's consideration that the justification for the adaption of the choir stalls was weaker here, the committee agreed not to recommend this aspect, urging that it be omitted from the scheme. It was also suggested that the retention of the chancel furniture largely as it is could be viewed as a gesture of mitigation to the amenity societies concerned with the changes elsewhere. The committee hopes that the removal of the modern altar rail will increase useable space in the chancel for musicians etc.
- The committee reiterated that phasing the proposals to include the west end facilities, lowering of the cleared section of pew platform and testing the moveability of the pews with a trial pew, would be sensible. However, though the church is a virtually unique, cohesive and successful example of early gothic revival architecture, it is nonetheless impractically narrow and this is always going to be a constraint. Concerns were raised that the proposals as they stand, if permitted, may result in an unhappy compromise, where the retention of eighteen pews, even if moveable, would still hamper the flexibility with which the gathering space can be used, and where neither the parish nor the amenity societies may be fundamentally satisfied with the outcome. The DAC therefore advised producing a comprehensive spatial audit which looks at all the options (including those possibilities outside of the building and using other buildings/shared spaces etc). It will be essential for the DAC and the chancellor to have sight of:
  - Evidence of the spaces used, when, where, by whom, for how long etc. A table has been provided in the statement of need which examines the different worship taking place and mission/outreach groups meeting, but it doesn't demonstrate which spaces the parish uses for them, and how these groups are expected to grow in number given this is something the parish anticipates. This is particularly pertinent for the Connections group as the parish's largest outreach group because this hadn't started at the time the last revision to the statement of need was made. This is key because DAC members of opposed views shared the same concerns at the meeting that it may be extremely challenging for the building, even with significant adaptation, to accommodate the current activities.
  - A plan showing how much space making all the pews moveable would actually free up, with all
    of the pews bunched up. (i.e. how many people can be accommodated in the flexible ways in
    which the parish conducts Messy Church and its Connections group)
  - o An assessment of how many people could be accommodated across the spectrum of flexible uses of the building with *all* of the pews removed. The parish may wish to consider, given the lack of consensus between the proposals, the DAC's views and those of the amenity societies, whether if this case were to go to Consistory Court, it would prefer the Chancellor to consider its original plan of removing all of the pews.

#### July 2023 Minute:

The committee agreed that there was clear justification for acquiring a new instrument in the church, given the age and fragility of the current organ. The committee appreciated that given the space restraints of the church, it was not possible to introduce a traditional pipe organ.

It was acknowledged that the DAC organ advisors had visited the church and discussed the options in great detail with the parish. The advisors raised concerns over the size of the proposed organ. It was highlighted that the organ proposed at Rotherfield Peppard had the same number of stops as the organs at All Saints Church, High Wycombe, and St John the Baptist Church, Windsor, both of which are large town centre churches.

A representative from the Church Buildings Council was present at the meeting. They highlighted that the size of the proposed organ was disproportionate to the size of the church and its choirs, and encouraged the parish to have a fresh evaluation of the proposals in order to source an organ which is a closer match to the scale of the building.

The committee shared concerns about the proposed position of the organ pipes. It was understood that the parish had shown consideration as to how a person might access the pipes at great height; however, it was still felt that the height posed a considerable risk to anyone trying to tune and maintain the pipes.

It is for these reasons, the DAC resolved not to support the introduction of the specified hybrid organ.

The committee were encouraging of the parish's aspiration to introduce an instrument which is exceptional in performance and musical versatility. It was advised that a smaller electronic instrument with around 30 stops, and speakers carefully positioned at the west end and in the Chancel, would do well to achieve the musical requirements of the parish.

#### July 2023 Minute:

The Committee agreed that in light of the previously undertaken work, the proposed colour of the new areas of limewash was not the primary concern. Instead, the committee noted again the patchy appearance of the previously applied ochre limewash and saw images suggesting that this finish was failing in a number of areas. The committee therefore requested that a sample area of at least  $2m^2$  is to be produced in advance of the works being undertaken. This is to be reviewed by sub-committee. It was noted that if a sub-committee cannot make the meeting within a timescale that allows the project to progress quickly on site then it may be appropriate for photos of the sample panel to be reviewed by the subcommittee via email. It was also agreed that a proviso should be included which ensures that there is to be no painting of bare stonework, following areas of bare stonework having been painted during the previous works. Concerns were raised regarding the potential of further wall paintings to be found in the church and it was agreed to include prior to commencing the redecoration works, 'a 2 square meter sample panel showing the proposed colour and finish must be prepared for review by a DAC sub-committee on a date agreed in advance of the area being painted'.

The DAC therefore resolved to issue a 'Not Object' Notification of Advice with the provisos discussed above to be included.

#### July 2023 Minute:

The committee was generally content to recommend the proposals, subject to:

- The canopy over the servery either being omitted (with the servery lidded) or made smaller so as to avoid clashing with the west window surround).
- The full detailed drawings (including panelling design), specification and schedule of work for the whole of the works (including associated works i.e. relocating memorials) being agreed with the subcommittee prior to the issuing of the NOA.
- The timber finishes for the new joinery, plus the choice of overflow chairs and tables being agreed with the CBO on site prior to these aspects being finalised.
- The usual provisos concerning CDM legislation, archaeology and wiring.

It was noted that these facilities will traverse the 13th century interior string course and that great care will be needed to ensure the junctions between joinery and the string course are treated sensitively. Lastly, contrary to the suggestion that the finer, older monument which is proposed to stay in situ would remain visible above the facilities on the south wall, the DAC was concerned the facilities would affect its visibility and so this would need to be explored with mock-ups, and provision made for this also to be relocated somewhere more dignified if that is the case. This could be agreed with the CBO.

# July 2023 Minute:

The DAC understood that the laying of the tombs had resulted in the destruction of two tombs that are believed to have been built in the late 18<sup>th</sup> Century/early 19<sup>th</sup> Century. The DAC could not identify any benefit to the parish or community resulting from these works.

The DAC heard that Cliveden Conservation had recommended the repair of the tombs less than 2 years ago. It was agreed that, had an application to lay the tombs been submitted prior to the works taking place, the DAC would have advised the parish to repair the tombs as recommended in the condition report.

The DAC concluded that there had been no reason put forward by the parish or Friends of St Mary's which justified the destruction of the tombs. It is for these reasons, the DAC resolved to not recommend the works for retrospective faculty permission.

The DAC were informed that large sections of the two tombs had been removed from the church and are believed to be in the possession of Cliveden Conservation. The DAC felt strongly that the missing pieces should be found and returned to the church. However, they did not feel it would be beneficial or necessary to rebuild the tombs. The committee agreed that the parish should take steps to trace the heirs at law descended from the persons commemorated on the tombs.

### July 2023 Minute:

The DAC heard the Archdeacon's concerns regarding the implication of the word 'Thanatophobic' which is included within the proposed design of this memorial. However, DAC members expressed differences of opinion as to whether this could be considered at odds with the doctrine of the Church of England, and noted that the proposal was likely to be pastorally sensitive.

The memorial also falls outside of the Churchyard Regulations due to its size, material and colour of lettering, but the DAC acknowledged that there were numerous other memorials similar in design already installed in this area of the churchyard, and as the proposed memorial is to be located within the churchyard extension it would not detract from the historic character of the churchyard. Concerns were expressed regarding the sustainability of the provenance of the stone of the memorial, and the DAC agreed that this issue should be looked into as a matter of policy. Dr David Knight of the CBC helpfully highlighted that Carlisle diocese are already looking into this issue and the Head of Church Buildings will be in touch with them to discuss prior to seeking further advice from DAC advisor Alex Wenham and preparing a suitable policy note for DAC consideration.

The DAC therefore resolved to issue a 'Not Object' Notification of Advice with the proviso that the grammar is corrected and the word 'thanatophobe' rather than 'thanataphobic' is used.
