# Privacy Notice for the Parents/Carers of Attendees of Yellow Braces Camp

### DIOCESE OF OXFORD

#### 1. Your personal data – what is it?

Personal data relates to a living individual who can be identified from that data. Identification can be by the information alone or in conjunction with any other information in our possession or likely to come into such possession. The processing of personal data is governed by the General Data Protection Regulation 2016/679 (the "GDPR") and the Data Protection Act 2018, (the "DPA 2018")

#### 2. Who are we?

Oxford Diocesan Board of Finance (ODBF) is the data controller (contact details below). This means it decides how your personal data is processed and for what purposes.

#### 3. How do we process your personal data?

ODBF complies with its obligations under the GDPR and DPA 2018 by keeping personal data up to date; by storing and destroying it securely; by not collecting or retaining excessive amounts of data; by protecting personal data from loss, misuse, unauthorised access and disclosure and by ensuring that appropriate technical measures are in place to protect personal data.

The information we collect comes from the following sources:

- Contact emails (camp enquiries) name, email address;
- Booking Form parent/carer's name, phone number, email address, address, your child's name, gender, date of birth, school year, church and parish, photograph;
- Medical and Consent Forms medical background, dietary requirements, email address, emergency contact details, phone number, medicines, vaccination information, blood group, NHS number, GP information;

We use you and your child's personal data for the following purposes:

- Contact Information Form used to contact you about our Yellow Braces Camps from your enquiry;
- **Booking Form** used to register your child for our Yellow Braces Camps - used to contact you for future camps;
- Medical and Photograph Consent Forms used to ensure we have all the relevant information on your child for their stay at camp.

## 4. What is the legal basis for processing your personal data?

We process the information you provide on the basis of 'legitimate interest' in the following way:

- Enquiries about our Yellow Braces Camps we will use the information you have provided to give you information on our camps;
- Registration for Yellow Brace Camp the information will be used to process your child's registration for camp and where consent given used to inform you of future Youth, Children and Family events;
- Medical and Consent Forms the information will only be used to ensure your child receives the best support and care possible for camp;
- Photographs are used for the purpose of identification in emergencies and for easy identification during camp by staff team;

#### 5. Sharing your personal data

Your personal data will be treated as confidential and will be shared when necessary with staff attending the Yellow Braces Camp, this may include sharing with medical professionals in case of an emergency.

#### 6. How long do we keep your personal data?

In accordance with the Church of England's current safeguarding guidelines, personal data connected with records of children's activity, including any risk assessment, will be kept for 50 years after the activity ends.

#### 7. Your rights and your personal data

Unless subject to an exemption under the GDPR or DPA 2018, you have the following rights with respect to your or your child's personal data:

- The right to request a copy of your personal data which ODBF holds about you;
- The right to request that ODBF corrects any personal data if it is found to be inaccurate or out of date;
- The right to request your personal data is erased where it is no longer necessary for ODBF to retain such data;
- The right to withdraw your consent to the processing at any time;
- The right, where there is a dispute in relation to the accuracy or processing of your personal data, to request a restriction is placed on further processing;
- The right to lodge a complaint with the Information Commissioners Office.

#### 8. Further processing

If we wish to use your personal data for a new purpose, not covered by this Data Protection Notice, then we will provide you with a new notice explaining this new use prior to commencing the processing and setting out the relevant purposes and processing conditions. Where and whenever necessary, we will seek your prior consent to the new processing.
