Staff Changes

Process Changes

The DAC heard that some changes to process have been made to ensure that the DAC agendas are moved through in a timely manner, whilst not curtailing helpful discussion of schemes. This has been found necessary due to the increasing number, scale and complexity of projects being considered by the committee and intends to make sure that proposal have the full benefit of input from site visit attendees and subcommittees. The changes are as follows:

- Site visit reports will be drafted by the case officer for inclusion in the next available DAC agenda and papers. Prior to inclusion in these papers the draft report will be circulated for comment to those members and advisors who attended the visit, who will have around a week to respond with comments on the draft.
- It is hoped that, wherever possible, site visit attendees will attend the DAC meeting at which the scheme is to be discussed, so that they can speak to the proposals.
- Photos of the church and the main drawings illustrating proposals will remain available on the powerpoint to aid discussion, but the case officer presentations of each scheme will be short and concise, to introduce the scheme and main points for consideration prior to input from the site visit attendees leading the discussion.

The DAC resolved to support the principle of the raised floor and inclusion of UFH with new stone finish on the proviso that a mechanical services engineer is engaged and their advice is obtained regarding the appropriate heat distribution system given the expected use pattern, that these figures are provided to the DAC, with a

revised location for the ASHP, details at all affected thresholds, and information on permeability of the proposed system, to be supplied to and agreed by the subcommittee prior to issue of a supportive Notification of Advice. The comments regarding the south transept floor should be noted and addressed within the detailed design. In addition, the DAC resolved to delegate the approval of the relocation, not removal, of the rood screen, to the subcommittee following on site discussions. The DAC restated a preference for an all timber chair and request that the tone of the chair is to be decided on and confirmed by the parish for consideration by the DAC subcommittee. The DAC resolved not to support the removal of any choir furniture at this time.

A subcommittee of the DAC to visit site to discuss the details of raising the floor and heating proposals, relocating the rood screen, and possible retention of a number of pews in the South Transept. The visit to take place once initial comments from the amenity societies are in hand, and a mechanical services engineer is on board. The scheme will not need to be considered at another meeting of the full DAC committee unless material changes are made to the proposals, or the subcommittee cannot come to a unanimous decision on the detailed aspects of the proposals.

January 2023 Minute:

The committee considered the revised design was very pleasing and more easily interpretable, improving on the first iteration. The DAC was pleased to see the revised design took on board the feedback from July's discussion of the application.

However, it was considered that in order to accommodate the changes, both quotations are truncated a little strangely. It was felt that if they have to be truncated, it was recommended that with the revelations passage, that the excerpt finishes after "And God shall wipe all tears away from their eyes, and there shall be no more death", and that the Under Turfy Grass should end after "they laid her bruised body", omitting "and the child, poor victims..."

Secondly, concerns were raised by the stained glass adviser as to the structural stability of the design as

proposed, particularly as there is one very large panel surrounded by smaller ones. The DAC shared this concern, but agreed to delegate the issuing of a supportive Notification of Advice once the subcommittee is content with the structural design, which, together with the fabrication and installation, ought to be carried out under the supervision of an experienced stained glass fabricator/installer.

The Chancellor has agreed to consider the revised scheme as a variation to the existing faculty rather t requiring a new faculty application. He has, however, required that a further public notice is displayed	

requiring a new faculty application. He has, however, required that a further public notice is displayed for the standard 28 days. The DAC was sympathetic to the parish's concerns regarding cost. However, considered that the proposed solution providing a smaller, flat roofed extension to the north side as currently set out by Christian Randall was unsympathetic to the character of the church, and, therefore, could not support this in its present form. The DAC took on board the parish's practical concerns regarding moving the extension eastward, thereby making circulation and serving from the kitchen more difficult as well as creating privacy concerns and necessitating the loss of pews in the north aisle. As no cost estimates were included in the supporting documents for each element of the design solution, the committee was unable to suggest alternatives which might satisfy the practical, financial and aesthetic goals of the project. The views of the

Local Planning Authority and the Victorian Society will also need to be gathered, and as such, the DAC delegated the proposal to a subcommittee, consisting of two DAC conservation architects and the Assistant Archdeacon. The subcommittee will work alongside the parish, LPA and Christian Randall to consider design possibilities which visually unite the two north side projections and avoid creating an area which may attract anti-social behaviour while reducing costs.

January 2023 Minute:

The DAC suggested that the draft site visit report was edited to suggest that the parish consider including EV charging points within the scheme since some of the new parking spaces are immediately next to the building, and also to state that the parish have agreed to phase 1 of the scheme being revised to include the part M compliant toilet. The DAC noted that the phase 1 alterations need to work as hard as they can for the parish, and did not feel this was presently being achieved and that the parish may want to work further with their architect on this - the loss of the creche was particularly regrettable. The need to stress that their cost plan should be made more robust to ensure they could actually afford either phase was also re-iterated.

The DAC ratified the draft visit report and resolved to support the principle of the proposals of phase 1, delegating the consideration of revised and comprehensive design details to a subcommittee of James Mackintosh and the Archdeacon of Buckingham ahead of issue of a Notification of Advice when this information is available.

The DAC was asked to consider the following:

- 1. Did the Committee consider that the parish's explanation of how they had demonstrated due regard for the net zero guidance was adequate?
- 2. Had the parish demonstrated that there is no viable non-fossil

The DAC resolved the following :

• While the committee agreed that the documents provided by the parish went some way towards demonstrating due regard to the net zero guidance, the general view emerged that these were not

sufficient. When this discussion was taken to a vote, 1 member of the DAC considered that the parish had demonstrated due regard for the Net Zero guidance, 8 members considered that due regard had not been sufficiently demonstrated and 1 member abstained. In addition, the Archdeacon, who was not in attendance, relayed that he believed that the parish had sufficiently demonstrated due regard for the guidance. Concerns centered mainly around the lack of external verification from the parish's boiler engineer regarding the faults with the existing boiler, its potential longevity and the cost of repairs. In addition, it was considered that the parish had not fully explored alternative solutions.

• The discussion then went on to the appropriateness of the proposal to replace the gas boiler like for like. Based on these discussions, the committee resolved that a Not Object, rather than a Not Recommend, Notification of Advice should be issued for the proposal. This resolution reflects the level of sympathy felt by the committee for the parish in this difficult situation.
