May 2024 DAC Minute:

The committee agreed that demolishing the existing building and subdividing the plot for up to four new-build houses and an augmented two-storey worship space is a sound way to proceed with the redevelopment proposals for this church. The DAC considered the latest plans would best meet the congregation and wider community’s needs, while doing so in a sustainable manner. The early sketch design shows a foyer/café on the ground floor, with a double height worship space beyond, and a kitchen, WCs and grocery store. The first floor would incorporate meeting rooms, office space and additional WCs, all accessible via a lift. There would still be space for a community garden within the plot, and parking for ten vehicles.

Because of the deprivation locally, there has been an understandable sense of wanting to avoid making any redeveloped church alienatingly smart or “shiny”. While the DAC understands this, it emphasised that it is nonetheless important that the new building offers a sense of being a church, something that, through its fenestration and detailing, the existing church succeeds in conveying. The new building design ought to offer a

sense of grace and spirituality as well as welcome, in both its massing and detailing. This is particularly and, perhaps, most easily possible through fenestration. Though very much of their time, the detailing of the Festival of Britain churches built during the 1950s in suburban Coventry by the likes of Spence and Gardner were good examples of how this can be achieved economically. The possibility of combining portal frame construction with shipping containers is being explored currently, alongside whether portal frame alone could be used, if the budget allows. The DAC, while supportive of the principle of this innovative idea, considered that the project team must assure itself of the longevity of this option, given what is built here should last for many decades.

While it isn't within the DAC's remit to comment on the financing of a project, the committee strongly urged the project team to seek legal advice on the viability of the proposed Christian Community Benefit Society finance option, and to ensure there are no hidden pitfalls associated with it.

The DAC considers that the direction the project is taking is the right one, and commends the incumbent and project team for both the vital mission and outreach which is taking place at Quarrendon, and their vision and dedication to the redevelopment scheme. The planners ought to be consulted at the earliest opportunity for their input in the revised scheme. The DAC looks forward to seeing this much-needed project develop.

May 2024 minute:

The DAC shared the concerns of the delegation over the size of the kiosk and the potential impact of the compressor unit on the historic masonry. The Amorino proposals would result in much more coverage of the courtyard area than the previous kiosks, making access for repair and maintenance difficult. The DAC expressed the view that a kiosk similar in size to the previous AMT kiosks would be more appropriate. Given the DAC's concerns about the size and quantity of development entailed by the current proposals, consideration should be given to whether it would be possible to provide a smaller kiosk with limited cold storage at the church whose supplies could be replenished from permanent storage at another location.

The committee ratified the site visit report which requests the following information before commenting in full on the proposals:

- The weight of the kiosk and details of any foundations that would be required for the kiosk and ancillary units. Would any excavations to form foundations be required?
- Accurate scaled plans and elevations of the units in the context of the church and courtyard.
- Would any of the equipment be sited within the root protection area of the tree and if so, what impact would this have on the tree? Crown lifting was discussed during the visit. Details of this should be included in the faculty application.
- A heritage impact assessment should accompany the application.
- Details of materials and colours of the cladding of the proposed units.
- Regular access is required to maintain the rainwater pipes from the porch and tower. What provision would be made for this? The parish should also consider how access for repairs to the tower will be provided once the units are in place.
- What provision will be made for refuse from the kiosk?

- The parish have also requested confirmation that there would be sufficient ventilation for the compressor unit for the cold store in both options. Further information about the temperature of the exhaust from this unit and its potential impact on the tower fabric is needed.
- Gelato is likely to be a seasonal item. It is understood that the vendor intends to switch to hot chocolate and waffles during the winter months. Confirmation that the kiosk would operate year-round should form part of the agreement.

A discussion of radiant chandeliers prefaced the following two applications. The committee noted that there is very little data available on the thermal impact of this type of heater on historic fabric. The Church Buildings Team will be working with central church to obtain funding to commission a study to look at the impact of existing installations on building fabric. Both EHS and Herschel would be invited to participate in this study. Concerns were also raised about the higher temperatures from the near infra-red units and whether it is possible to turn them down to improve comfort of those sitting below them.

The DAC accepted the need to replace the aging heating installation before it fails is clear. While the statement of significance fails to adequately acknowledge the significance of the nave, the harm to the significance which			

might be caused by the chandeliers would be largely reversed if they are removed in the future. The DAC resolved to issue a *Not Object* NOA subject to the following provisos:

1. The QI architect, M&E consultant and the manufacturer to agree the chandelier motif and the installation design, layout and installation in consultation with the DAC subcommittee to mitigate the potential for harm to the historic fabric.
2. The following information is to be submitted for agreement by the DAC subcommittee prior to commencement of work:
 - a. Finalized plans and sections, to scale, of the proposed installation.
 - b. Structural engineer's assessment showing that the arcades can support the weight of the chandeliers.
 - c. An independent assessment of the environmental and conservation risks to be instructed by and with funding from the diocese, to help assess whether the proposed design will minimize these risks and maximize the benefit of the system to church users.
 - d. Details of the proposed resultant lighting levels and assessment of whether the lights should be omitted from the chandeliers to be agreed.
3. Following installation, a further independent environmental survey with thermal imaging to be instructed by and with funding from the diocese, to assess the performance of the installation in respect of the needs of the parish, the conservation needs of the historic fabric and the impact of moving from one form of heating to another.
4. The existing heating installation to be retained for a period of 5 years to allow further monitoring of the effectiveness of the proposed installation. Should it be found that it is causing harm, then use of the installation should cease until steps are taken to mitigate this harm. This could include removal of some or all of the proposed units.
5. A record of the hours of use and the costs in use is to be kept for a period of 12 months and submitted to the DAC.
6. All electrical works to be carried out in accordance with diocesan guidelines:

7. A further site visit to be arranged with members of the subcommittee and the QI architect to be carried out to agree the proposed cable routes.

Details of any excavations in connection with the installation of the new power supply to be submitted to the DAC subcommittee to determine what if any archaeological mitigation is required.

May 2024 minute:

In April 2023, the parish wrote to the CBO requesting to revert back to the EHS proposals due to the higher cost of the Herschel Halo chandeliers. A draft letter to the Chancellor explaining the background to the DAC's decision to issue a *Not Object* NOA for the installation of the Halo heaters in September 2023 was reviewed by the committee. The letter asked the Chancellor to advise whether he would be content to consider the change of chandelier unit as a variation to the existing faculty or whether a new faculty application would be required. Should the Chancellor be content that the proposed change could be considered as a variation, the letter then asks whether he would be content to issue the variation.

Given the potential precedent that would be set both for the installation of this type of near infrared chandelier in other churches in the diocese and as a means for parishes to subvert the DAC's original recommendation in respect of them, the DAC resolved to **Not Recommend** the variation to the faculty to allow the installation of the Toshiba/EHS heating chandelier.

The DAC was content to issue a Notification of Advice recommending the proposed removal of eight pews and the pulpit, and lowering the AV screen, subject to consultation with the Victorian Society, the 20th Century Society and the LPA. The committee emphasised that Holy Trinity is a church which would benefit from a holistic approach to rationalising its interior, and recommended analysing how the building is used and how it could be improved in terms of being a cohesive space. To that end, the committee considered that if it were so desired, further pews, or indeed all of the pews, could be removed, subject to an application being made.

May 2024 Minute:

The DAC encouraged the parish to continue to develop the proposals for placing a kitchenette in the tower with the dishwasher located in the existing kitchenette at the west end of the north aisle if possible to reduce introduction of additional moisture in the tower. The DAC resolved to delegate resolution of details of the proposals to a subcommittee consisting of Dr Nicola Coldstream, Mr James Mackintosh, Ms Sarah Tattersall and Mr Alex Wenham following which a Recommend Notification of Advice can be issued. These details should include:

- Structural engineer's report on the tower masonry and action plan for its repair following on from recommendations in the 2018 QIR.
- Details of and method statement for drilling through the tower masonry to introduce services.
- Proposed location and method statement for potential relocation of brass memorials from south wall of tower.
- Revised proposals for the cupboards on the south wall of the tower.

May 2024 DAC Minute:

The DAC was minded to agree to the removal of the eight pews, but raised concerns about the replacement chair proposed. It was considered that the Rosehill upholstered blue chair is aesthetically inappropriate for a historic listed church and the blue upholstery will dominate the interior in a way which would detract from the building's character and cohesive appearance. The CBC's guidance on chairs discourages the use of upholstery in churches on grounds of aesthetics, durability, and stacking limitations. The committee was concerned that the PCC could be replacing one set of inflexible furniture with new furniture which is nearly as inflexible, but inferior. As such the DAC preferred instead a non-upholstered stacking chair which would have the advantage of being more lightweight and able to stack in greater quantities. The committee was content to delegate agreement for the type and finish of chair and table to the subcommittee.

The DAC was content to issue a Notification of Advice recommending the works subject to 1) the subcommittee agreeing a more suitable chair with the parish, 2) consultation with Historic England, the Victorian Society and the LPA, and 3) the floorboards being toned down so as to blend in better with the existing joinery in the church.
