Previous DAC Minute:	<ul> <li>which has now been cast.</li> <li>May 2017: The principle of the restoration of the bells and reinstatement of ringing at Longworth is understandable and encouraged by the DAC. It is recommended that the parish provide the following information in preparation for submitting their faculty application online.</li> <li>Demonstrate by means of a sectional drawing that the existing bell frame cannot be elevated above the ringing chamber or kept in its current position with a new frame installed above.</li> <li>A firm and detailed proposal for the relocation of the existing bell frame.</li> <li>A statement of need that explains the justification for the plans. This must includ the reasoning behind increasing the bell ring to six and an explanation of the number of bell ringers at Longworth whom are committed to the long-term futur of bell-ringing at St Mary's.</li> <li>As sally guides will need to be installed to enable ringing from the body of the church and elevation of the west wall as existing and proposed should be provided, demonstrating the height of the sally guide and any interference this will have on the window.</li> <li>To be included within the statement of need or a separate document, the paris must show that they have considered the comments from the Church Building' Council and have either accepted them or are giving reason to contest them.</li> </ul>							

### Sept 22 Minute:

The DAC resolved to support the principle of the scheme but expressed concern about the viability of income generation from the establishment of a ringing school at the church. Fresh consultations with local residents should take place as early as possible, and the parish may wish to temporarily install a speaker system to replicate the expected volume and frequency of bell ringing. The DAC resolved to delegate the consideration of details of the scheme, particularly the treatment of the tower steps, decision on what elements of the frame are to be retained within the church (following full archaeological investigation being undertaken during the dismantling)

details of the sound attenuation methods proposed and the specification for the tower repairs, to a sub committee prior to a supportive Notification of Advice being issued.

The DAC encouraged the parish to develop their Statements of Significance and Need but resolved that, should the SCBO be content that these documents clearly demonstrated an ongoing need from that established in 2014, then a supportive Notification of Advice for either option 'B' or the 2014 scheme could be issued upon receipt of the necessary technical details. In either case the amenity societies will need to be reconsulted, and it may be beneficial to ask them to comment on both the present and 2014 options to inform the PCCs decision when selecting which version of the scheme to progress with.

The DAC noted that a plastic folding chair was not felt appropriate for use in the historic church and, as there are not many required, suggested the parish consider the unupholstered timber Treske folding chair which would continue to provide temporary seating with a minimal storage requirement but in a more appropriate material.

#### September 22 Minute:

The DAC resolved issue a Recommend Notification of Advice subject to the following provisos:

- Detailed proposals for the infill of the aisle to create a dais and making good of the base of the pulpit to be submitted for approval by the subcommittee prior to works commencing on site.
- Cable routes for new lighting to be agreed with the project architect in advance.
- Electrical works to be in accordance with the diocesan electrical guidelines.
- The proposed heating installation to be in accordance with the proposal from Cooltouch.
- Repairs to the font are not included in this consent.
- It is suggested that an acoustician is asked to analyse the impact of inserting an enclosure for facilities at the west end of the church.
- It is suggested that the parish establish how much the Royal Academy are likely to continue to use the church for concerts and recording.
- It should be noted that the single remaining pew door was attached to one of the pews to be relocated. This should be retained and relocated if possible.

Previous DAC Minute:	Provision of WC and servery at west end of church  May 2004 minute:  The delegation reported on proposals to create a gallery with WC and tea-making facilities below at the west end of the church. It was also intended to make the existing vestry secure to allow the church to be open during the day. Consideration was also being given to opening the blocked south doorway and inserting glazing to give a mor open feel to the church. This would require a careful design and there would need to be consultation with the planning authority and others. The DAC considered that the right approach was being taken to meet the needs of the congregation and encouraged the parish to develop the designs.					

Subject to consultation with Historic England and the relevant amenity societies, a Recommend Notification of

Advice could be issued subject to the parish agreeing to make the following amendments:

- Options for providing a fully accessible WC are explored further. This may result in the need to relocate the font or site the WC on the south side of the nave.
- The proposals should be revised to provide a symmetrical enclosure on both sides of the central entrance.
