

Volunteer Safeguarding Trainer Role Description & Person Specification

Main purpose of the role

Safeguarding learning supports all those who have a role within the Diocese of Oxford to implement best safeguarding practice and to effectively recognise and respond to safeguarding situations.

Volunteer safeguarding trainers play a vital part in this, sharing their skills, time and talents to facilitate safeguarding learning opportunities for church officers and parishes. Volunteer Trainers support the Diocese of Oxford to work in line with The Church of England <u>Safeguarding Learning and Development Framework (2024)</u>.

Responsibilities - what will you be doing?

- Use the Diocese of Oxford training materials to deliver Core and Specialist safeguarding learning pathways.
- Travel to training locations across the Diocese of Oxford or deliver safeguarding learning over Zoom.
- Support participants in learning and developing the skills and knowledge to create a safer church.
- Keep records of all safeguarding training delivered and submit Attendance Form and Evaluation Forms to the Training Adviser.
- Maintain good communication with the Training Adviser in order to review safeguarding training, discuss potential challenges or concerns and apply feedback and advice.
- Participate in train-the-trainer sessions and volunteer training meetings, in order to keep safeguarding knowledge and trainer skills up to date.

Location and hours - when and where you will be doing it?

Hours would be dependent on the level of involvement of the volunteer, in terms of the number of learning pathways they deliver and will fluctuate. Approx 5 hours per month. In-person safeguarding learning may be at locations across the Diocese. Online safeguarding learning would be home-based.

- An induction into your role
- A 'settling in' or 'trial' period
- Ongoing support, accountability, oversight and supervision
- Train-the-trainer sessions and trainer team meetings

- Confident at managing group dynamics
- Effective listening skills
- Confident in dealing with emotional and personal contributions from participants as well as managing the time and learning points effectively
- Strong organisation and timekeeping skills
- Comfortable using Microsoft Office, the internet and email
- Prepared to learn, develop and undertake training
- Ability to volunteer on evenings and weekends
- Approachable for participants to feel comfortable raising questions or concerns
- Reliable

- Experience of undertaking a safeguarding related role
- Previous contact with children or vulnerable adults
- Willing to travel to training venues across the Diocese of Oxford
- Experience of using Zoom to deliver learning or hold meetings
